



## Modern Slavery Statement

Ten Lifestyle Group Plc is committed to preventing acts of modern slavery and human trafficking from occurring within both its business and supply chain and imposes those same high standards on its suppliers.

### TEN'S STRUCTURE

Ten Lifestyle Group Plc, together with its subsidiaries (the Group), is a provider of lifestyle and concierge services globally with its head office in London, United Kingdom. The Group has around 1,200 employees worldwide, operates in over 20 countries in the EMEA, APAC and the Americas regions, with an annual turnover of £63m (FY 2023). In May 2023, Ten Lifestyle Group Plc obtained B Corp certification, underlining the Group's commitment to responsible business practices and the highest standards in social and environmental performance, transparency and legal accountability.

The Group works with a range of third-party suppliers and partners including hotels, restaurants, retailers, ticketing outlets and technology providers. The Group's business is organised into geographical business units across markets in Europe, AMEA and the Americas.

### OUR POLICIES ON MODERN SLAVERY AND HUMAN TRAFFICKING

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. This anti-slavery and human trafficking policy reflects our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure modern slavery and human trafficking is not taking place anywhere in our supply chains.

### DUE DILIGENCE

In efforts to monitor and reduce the risk of modern slavery and human trafficking occurring within our supply chains, we are developing a risk rated framework to identify and mitigate risk by putting in place systems to:

- Identify and assess potential risk areas in our supply chains.
- Mitigate the risk of modern slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

### SUPPLIER ADHERENCE TO OUR VALUES

We have a zero-tolerance approach to modern slavery and human trafficking. Our suppliers' obligations in relation to modern slavery prevention are set out in our [Supplier Code of Conduct](#). To ensure all those in our supply chain and contractors comply with our values we have in place a supply chain compliance programme managed by our compliance team, which consists of involvement from the following departments:

- Legal and compliance
- Proposition
- IT & Infosec
- Finance

### TRAINING

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide training to our staff. We also require our business partners to provide training to their staff and suppliers and providers.

## **EFFECTIVENESS**

The Group's Senior Leadership Team lead reviews into the effectiveness of our training and controls to ensure that modern slavery and human trafficking is not taking place in any part of our business or supply chains, using the following key performance indicators (KPIs):

- Vetting. The percentage of suppliers and sub-contractors that have been vetted for ethical labour practices.
- Whistleblowing. The number of reported breaches in the past year.
- Training. The number or percentage of staff trained.
- Remedial action. The instances of remedial action being needed.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our Group's modern slavery and human trafficking statement for the financial year ending 31 August 2023. This statement was approved by the board of directors on 28 March 2024.
